7. General Terms & conditions for the accommodation services :

8. Cancellation and Refund Policy :

Over 30 days prior to check-in date : 90% of the total amount refund. 15-30 days prior to check-in date : 75% of the total amount refund. 15-7 days prior to check-in date : 50% of the total amount refund. Less than 7 days prior to check-in date : no refund will be made. Refund will be done within 15 to 30 days, according to Credit Card Company Policy.

By signing this Agreement, the guest agrees to and accepts all terms of this Agreement, and allows NYC-STR to collect in-advance the full accommodation charge , and any extra charges for additional services , purchased by the guest (transportation, phone calls, communication services, touristic services, etc.).
